## MAY REVISION OF STATE BUDGET BRINGS GOOD NEWS

The May Revision to the 2015-16 budget, released on May 14, reflects an increase in the state's general fund revenues of \$6.7 billion more than estimated. **Governor Brown** said at his press conference, "The finances of California have stabilized. We're balancing our budget and just since January several billion dollars have come into the state treasury." The May Revision focuses on the Local Control Funding Formula (LCFF), federal health care reform, public safety realignment, the Water Action Plan and the Cap and Trade expenditure plan. It also includes an earned income tax credit that will help low- and moderate-income workers.

The revised budget brought especially good news to public education as an additional \$5.5 billion will go to K-12 schools and community colleges, based on the provisions of Proposition 98. Per pupil funding for K-12 schools will increase by more than \$3,000 compared to 2011-12 and \$700 more than districts anticipated when the 2014-15 budgets were developed, with most of it being distributed through LCFF. The May plan proposes a \$60.1 million increase to early education programs, provides more money for training in the Common Core State Standards, increases support for career technical education, eliminates the allocation boards previously required in the Adult Education Block Grant program, allocates funding for increasing access to early interventions for special needs children and provides an additional \$619 million to community colleges.

LAUSD will receive an additional \$300 million to \$400 million, which will close a projected deficit for next year and will cover the costs of recently approved raises. **Superintendent Ramón Cortines** said the additional funds will particularly benefit the District's homeless, foster care and low-income students. In March, layoff notices were sent to 609 teachers, counselors and social workers, and the Board of Education will be discussing how the additional funding will impact these employees at the meeting on June 9, 2015. Another priority identified by Board President **Dr. Richard Vladovic** and Board Member **Steve Zimmer** is support for the 63% of tenth-graders who may not receive diplomas because they are not succeeding in the required college-prep curriculum.

## ELECTION RESULTS

Final results in the election for representatives of Districts 3, 5 and 7 of the LAUSD Board of Education brought mixed emotions for AALA-supported candidates. **Dr. Richard Vladovic** and **Scott Schmerelson** won their races, but incumbent **Bennett Kayser**, a staunch supporter of students,

administrators and teachers, was defeated by charter school founder **Dr. Refugio “Ref” Rodriguez**. As **Dr. Diane Ravitch** says in her blog, “So, the election...is a wash. Not a victory for the charter industry, not a loss for public education. A wash.”

The voter turnout was low, with less than 8 percent of eligible voters casting ballots and absentee ballots figuring heavily in the final tally. **Scott Schmerelson** won by the greatest number of votes—3,000 votes ahead of **Tamar Galatzan**; while Dr. Rodriguez obtained only 1,700 more than **Bennett Kayser**. **Dr. Vladovic** won by 2,000 votes. It is disheartening that so few voters made it to the polls in an election that will have a major impact on decision-making in LAUSD, which is the second largest school district in the country.

This election was also unique in that political action committees spent 15 times the amount they did six years ago hoping to swing the ideological composition of the Board of Education. The biggest spender was the California Charter Schools Association’s PAC which used more than \$2 million to oppose incumbent Bennett Kayser. These committees’ donors will not be completely known until August as reporting is not required until then.

New members of the Board of Education take office on July 1, 2015, and must immediately start to make decisions about a new teacher-evaluation system, a retooled student technology plan, a new superintendent and whether the current A-G graduation requirement is to stay in place. Given these critical issues, we are delighted that trilingual Scott Schmerelson is joining the Board, bringing with him the experiences of having actually worked his entire life in education. He joins veteran educators Dr. Vladovic, **Dr. George McKenna**, **Steve Zimmer** and former attorney-turned-teacher **Mónica Ratliff**. AALA, as the voice of District classified and certificated administrators, is pleased that there will be so much depth of knowledge about how schools actually operate and how students learn on the Board.

## **LAUSD 2015-2016 SCHOOL-BASED ADMINISTRATOR COMPENSATION PLAN NOW AVAILABLE**

The District’s School-Based Administrator Compensation Plan (SBACP) has been updated for the 2015-2016 school year. The SBACP continues to be based on:

- School type (i.e., Elementary, Secondary)
- 3-year average student enrollment
- Classification/position alignment (i.e., principal, assistant principal)

The following criteria and conditions were identified through a job study of all principal and assistant principal classifications and is the foundation for the SBACP methodology:

- Difference in job complexity among principal and assistant principal classifications
- Equitable schedule difference between principal classifications
- Equitable schedule difference between assistant principal classifications
- Historical alignment among principal and assistant principal classifications

**HEALTH BENEFITS FAQ:  
MEDICARE, DEPENDENT COVERAGE AND ANTHEM EPO**

**I am an active employee approaching age 65 and I don't plan to retire for a few more years. Should I apply for Medicare?**

Medicare allows you to apply even if you are still working. However, you may hold off applying for Medicare until you actually retire. At that time you will apply for both Parts A and B. If you decide to apply for Medicare while still working, do **not** enroll in Part B because you will have to pay premiums.

**My daughter turns age 26 in July 2015 and will no longer be eligible for coverage under my plan. I know she'll be offered COBRA coverage, but won't premiums be less costly on the *Covered California* health exchange marketplace?**

COBRA coverage information, by law, will include information regarding health coverage alternatives offered through the marketplace. At age 26, your dependent should be able to make an informed decision about her health care options by comparing the coverage and premiums offered through COBRA and the coverage and premiums through *Covered California*.

**Why does my Anthem Blue Cross EPO member card have PPO printed on it? I know this plan is not a PPO plan where members can go to any licensed medical practitioner.**

Your Anthem Blue Cross medical plan is called Exclusive Provider Organization, which means that you must utilize in-network doctors. The confusing part is that the Anthem Blue Cross network of participating providers is called Preferred Provider Organization, or PPO. As an EPO insured member, you must select your services from participating in-network physicians, medical groups and facilities. The EPO plan does not pay for services rendered by out-of-network doctors. Some exceptions apply.

**I am a Medicare retiree with Anthem Blue Cross EPO coverage. I know that the District pays higher premiums for our supplemental coverage than plans such as those offered by AARP and others. Why are the costs so high?**

District premiums are higher due to the high-quality prescription plan included. Remember that District Medicare retirees do not enroll in Medicare Part D, nor pay the Part D. The District-provided CVS CareMark plan for EPO subscribers is better than the Medicare Part D plan—it has no *donut hole* for drugs and offers an expanded list of permitted medications. Additional differences for EPO plan members include:

- Prescription coverage premium – **District plan, none** (for members); Medicare Part D subscriber, from \$12.30 to \$70.80 per month on a sliding scale, or \$147.60 to \$849.60 per year.
- Annual deductible – **District plan, none**; Medicare Part D subscriber, \$320.
- Annual coverage limit – **District plan, none**; Part D subscriber, \$2,960\*.
- Out-of-Pocket (Catastrophic) Threshold – **District plan, none**; Part D subscriber, \$4,700\*.

\*After spending \$2,960 in out-of-pocket costs for prescriptions in 2015, Medicare Part D subscribers reach the *Coverage Gap* or *Donut Hole*. Once in the coverage gap, Part D subscribers pay 45% of the full retail price of covered brand-name prescriptions and 65% of the cost of generic drugs until they reach the catastrophic threshold of \$4,700. After \$4,700, copays become reduced significantly for the rest of the year.

## STUDENTS FILE CLASS-ACTION LAWSUIT

Five high school students and three teachers from Compton Unified School District have filed a lawsuit against the District for allegedly failing to address the effects that chronic trauma had on their learning ability. The students said that the poverty, violence, neglect and abuse that they faced in their daily lives resulted in complex trauma and should qualify as a disability under the Americans with Disabilities Act and Section 504 of the Rehabilitation Act. If so, it would enable them to receive special academic and mental health services that the school would be required to provide. The lawsuit, *Peter P. v. Compton Unified School District*, was filed on behalf of the students by Public Counsel and another law firm working pro bono.

It is well known that trauma has a negative effect on students and those who have experienced it are far more likely to repeat a grade, have attendance and behavioral problems, lower reading scores and other problems. Recent research shows that trauma can cause children to be in a constant state of fear, making it difficult for them to relax enough to process verbal instructions and learn. According to the *Los Angeles Times*, the lawsuit is seeking training for district staff to recognize trauma, mental support for students and a shift from punitive disciplinary practices to those based on reconciliation and healing (May 19, 2015). The plaintiffs include students who have suffered physical violence, sexual abuse, witnessed several shootings, been homeless and shuffled between foster homes. One student slept on the roof of the high school for two months because he was homeless and when he was discovered, he was suspended.

One of the teachers in the suit is an alumnus of Dominguez High School and has taught there for 19 years. Despite losing dozens of students to violence and attending from one to three funerals a year for current or former students, he has never received training on trauma or mental health nor been made aware of any

system for referring students for mental health services. He joined the suit because he wants more training and support.

**Mark Rosenbaum**, an attorney with Public Counsel, says that focusing on childhood trauma would do something about the achievement gap and while society may not be able to eliminate causes of trauma, schools must address its effects.

Monday, May 25, 2015, is Memorial Day, originally called Decoration Day, a day of remembrance for those who have died in service to the United States of America. The first Decoration Day was a result of the Civil War and was held on May 30, 1868, by order of **General John Logan**, national commander of the Grand Army of the Republic. The order read, "The 30th of May, 1868, is designated for the purpose of strewing with flowers, or otherwise decorating the graves of comrades who died in defense of their country during the late rebellion, and whose bodies now lie in almost every city, village and hamlet churchyard in the land."

The first state to officially recognize the holiday was New York in 1873. By 1890, it was recognized by all of the northern states. The South refused to acknowledge the day, honoring their dead on separate days until after World War I (when the holiday changed from honoring just those who died fighting in the Civil War to honoring Americans who died fighting in any war). It is now observed in every state on the last Monday in May with the passing of the National Holiday Act of 1971. Alabama, Florida, Georgia, Louisiana, Mississippi, South Carolina and Texas have an additional separate day for honoring their dead Confederate soldiers.

The National Moment of Remembrance resolution, passed in December 2000, asks all Americans *to voluntarily and informally observe in their own way a moment of remembrance and respect, pausing from whatever they are doing for a moment of silence or listening to Taps* at 3 p.m. local time on Memorial Day.
