## **LAUSD HERE I COME (Cont.)**

It is important to note that AALA sees **Ms. King's** appointment as an auspicious opportunity to garner increased support for one of the hardest working segments of the District, the middle manager. Ms. King, as Chief Deputy Superintendent, was instrumental in carrying AALA's message to Emeritus Superintendent **Cortines** regarding the exorbitant number of meetings and the lack of a service-oriented and supportive culture and climate for classified and certificated middle managers. As a result, a moratorium on meetings occurred and a stern reminder of how offices at every level of the organization exist to support middle managers. Author Jim Collins has said that "good is the enemy of great" – and in the context of public schools, that means that being good can lead to a culture of "being good enough." This culture does not serve our students best. AALA shares Superintendent King's and the Board's vision of making the Los Angeles Unified School District the best in the nation. AALA's sleeves are rolled-up and ready to work with the entire school community to make LAUSD not merely good, but indeed great.

## **NEW LAWS AFFECTING EDUCATION**

There are 807 new laws that became effective in 2016. Several have implications for education and educators. Here are some highlights from the *Los Angeles Times*:

- Parents cannot waive the school district's immunization guidelines for personal beliefs.
- The state minimum wage is \$10 per hour.
- The California High School Exit Exam has been suspended for three years, pending the development of an alternative. Also, students who did not pass the exam, but met all other graduation requirements, can now receive a diploma.
- Schools must provide places for students to breast-feed or pump breast milk.
- High school health courses must include lessons on preventing sexual violence.
- Students are now required to take sexual health classes, unless parents object, and the classes must be inclusive of different sexual orientations.
- Future history textbooks must include a section on the 1930s deportation of U.S. citizens of Mexican descent.
- Community colleges may suspend or expel students accused of sexual assault that occurs off-campus.
- Schools cannot build a new marquee, sign, or other fixtures bearing the team name *Redskins*, and by 2017, all must eliminate the use of the word for mascots and team names on uniforms and in yearbooks.
- The California Interscholastic Federation is required to classify competition cheer as an official interscholastic sport.
- People with permits to carry concealed weapons are not allowed on college campuses (closes a loophole in previous law).

## GOVERNOR'S PROPOSED BUDGET BRINGS GOOD NEWS

**Governor Jerry Brown** released his 2016-17 budget proposal last week and it brought kudos from educators throughout the state. Public K-12 schools and community colleges will receive an additional \$5.4 billion, with per-pupil spending increasing by \$368 to \$10,591; with added revenues, the amount for each student rises to \$14,500. This reflects an increase of 30% in funding since the peak of the recession. The budget came with a warning. The Governor cautioned that the state's revenues may fall, because, "...everything that goes up, comes down."

The proposed budget provides \$71.6 billion for public K-12 schools and community colleges, an increase of \$2.4 billion from this year. The Local Control Funding Formula (LCFF) received 95 percent of full funding. Programs outside of LCFF — special education, child nutrition, foster youth, preschool, and American Indian Education Centers also received increases. An early learning block grant is included in the proposal, with its use left up to local school officials. Charter schools received an increase of \$61 million, plus \$20 million more for new charters.

Governor Brown appears opposed to the Public Education Facilities Bond Initiative (on the ballot in November), a \$9 billion school facilities bond measure that will cover repairs, remodels, and expansions for K-12 schools and community colleges. He said that it is *overly complex* and *costly*.

As is typical in politics, members of both parties found the Governor's proposed budget promising and lacking. Much negotiation will take place before the final budget is produced in May.

## HEALTH BENEFITS FAQ— THE LONG-TERM EFFECTS OF JOGGING

### **How fast a pace is considered jogging?**

Many experts say that jogging involves a pace less than 6 miles per hour. A recent large-scale study defined “average” jogging at less than 5 miles per hour, or a 12-minute mile. Other definitions use heart rate at 50 to 80% of one’s maximum heart rate, calculated at subtracting your age from 220. More strenuous jogging would be considered “running.”

### **Does jogging lead to osteoarthritis with implications for knee replacement?**

There’s a common belief that long-term jogging increases arthritis risk, even though exercise experts have claimed the opposite. Recent research on the impact of physical activity on the knee joint, found that weight-bearing physical activities, such as jogging, do not compromise joint health. You may have a genetic predisposition for osteoarthritis, or have other contributing factors such as prior knee injury, being overweight, having physical issues not conducive to running, but slow-paced jogging is not only safe, but beneficial to one’s health.

### **What has research shown about jogging?**

Two major studies provide the most recent findings:

*Copenhagen City Heart Rate Study (2015)*

- One to 2.4 hours per week of jogging at a slow or average pace is associated with the lowest death rate.
- Both not jogging and too strenuous running are linked to higher rates of death.

*Stanford Study (2008)*

- Regular, long-term running slows the effects of aging. Study followed 538 runners over age 50 for 20 years.
- Onset of disability occurred 16 years later for runners than nonrunners.
- Runners do not have greater rates of osteoarthritis; they don’t require more total knee replacements than nonrunners.
- Running slows cardiovascular deaths and is associated with fewer early deaths from cancer, neurological disease, infections, and other causes.

### **What are some guidelines I can follow to start a slow-paced jogging routine?**

- Consult your doctor before starting. Jogging may aggravate physical issues, such as prior knee or foot injuries or a heart condition.
- Purchase good shoes. Work with a shoe specialist to help select shoes with the right arch support and cushioning to match your stride.
- Begin gradually by walking and then adding short jogging spurts. Several websites offer programs that gently move you into jogging. These sites include: [How to Start Jogging](#), [How to Start Running](#), and [10 Tips for Beginning Runners](#).
- Start out by warming up and stretching. End by cooling down and stretching.

- Take precautions to avoid injury. Avoid running on uneven or sloped surfaces. Stop jogging if you experience pain. Ice and rest the area for two to three days before trying to jog again. See your doctor if pain persists. Remember, you don’t need to jog strenuously to maximize jogging’s health benefits.

## **SERVING ENGLISH LEARNERS**

ALA thanks **Hilda Maldonado**, Executive Director, Multilingual & Multicultural Education Department, for providing this article.

"Serving English Learners, who make up nearly one-quarter of our public school students, is one of my top priorities. We are eager to carry out the terms of this settlement, including adding staff and providing additional guidance to districts, so together we can make sure English Learners get the support they deserve." –**Tom Torlakson**, California Department of Education.

As part of the settlement of a lawsuit involving English Learners, *D.J., et al. v. State of California, et al.*, the State Superintendent of Public Instruction recently described several steps the California Department of Education will take to ensure all English Learners receive instruction. These include:

- Sending additional reminders to local educational agencies of their legal obligation to provide English Learners with appropriate language instruction.
- Modifying the California Longitudinal Pupil Achievement Data System (CALPADS) to make it easier to determine whether a course provides English Learners instructional services.
- Modifying the way CDE monitors English Learner programs.

What does this mean for LAUSD, the district with the largest enrolling English Learner population in the nation?

During the LAUSD Board of Education meeting on August 26, 2014, Guadalupe, a 9<sup>th</sup> grade student from Banning HS, reported that while she was initially disappointed at not being able to have an elective due to the additional ELD class requirement, she was grateful for the support of the EL Coordinator, the Title III coach, teachers and her parents. The support she received from her school and family helped her gain proficiency in English and finally reclassify. English Learners who reclassify outperform all other subgroups in state and district assessments. These reclassified students have been served and supported properly by caring staff who ensure that they receive the additional instructional services they need to acquire and become proficient in English.

The modification the CDE has made in CALPADS provides an opportunity to demonstrate the instructional supports provided in LAUSD to English Learners like Guadalupe. We can no longer simply rely on the teacher credentials or authorizations, nor make a blanket report that all courses provide English Learner services. The class/course coding that will be entered in MiSiS enables our district to comply with the state's settlement and ultimately ensures that CALPADS reports properly represent our district's commitment to English Learners. We are grateful to the MiSiS team for programming the new requirements over the winter break. Principals will now be required to certify the class/course English Learner services being delivered by teachers in class/course sections. While this may create an initial burden on staff, in time the scheduling and coding will become part of the routine services provided to our English Learners. Central Office and local district counseling and English Learner staff will be deployed to support principals during the month of January to ensure we meet the CALPADS reporting due date.
