VOTE FOR AALA ENDORSED CANDIDATES

Tuesday, March 7, is Election Day and we urge all AALA members to exercise their right to vote. We anticipate that the voter turnout will again be low, even though there are critical positions that need to be filled. In the election for three seats on the LAUSD Board of Education, a record amount of money has been spent, heading it toward being the most expensive school board vote in the country. The three seats on the LAUSD Board of Education that are open are in Districts 2, 4, and 6 and several candidates are on the ballot with more than \$4 million in outside spending taking place. All three races are hotly contested and charter school and education reform supporters alone have spent about \$2.6 million so far. Once the election has been held, the winners will join the other Board Members in balancing the budget and making significant decisions while seeking ways to stem the decline in student enrollment and address teacher shortage in key areas. AALA's PAC spent many hours interviewing the candidates for the Board of Education and has selected three candidates to endorse. These candidates are true advocates for public schools and are supportive of AALA's core values (click [HERE](#)).

Current Board President **Steve Zimmer** has received AALA's support in his bid for reelection in District 4. He has three opponents and this race has become particularly nasty, with the Charter School Association's political action committee distributing numerous flyers that attack not just Zimmer's politics, but virtually hold him responsible for the iPad debacle and the molestation cases. Former Mayor **Richard Riordan** has donated \$1 million to try to unseat Steve Zimmer. During his years on the Board of Education, Zimmer, a former teacher, has been a dedicated, strong advocate for administrators and teachers and opposed to increasing the number of charter schools. His platform includes bringing the community together to create

change in schools and public education, increasing access and equity for every student to fulfill his/her dreams, supporting bilingual education, helping Dreamers, and 100 percent graduation. In addition to AALA, he has earned the support of the Los Angeles County Democratic Party, Planned Parenthood, Stonewall Democrats Club, United Teachers Los Angeles, Service Employees International Union Local 99, Armenian National Committee of America, Los Angeles Mayor **Eric Garcetti**, California State Superintendent of Public Instruction **Tom Torlakson**, Congresswoman **Maxine Waters**, Congresswoman **Judy Chiu**, and Los Angeles County Supervisors **Hilda Solis** and **Sheila Kuehl**.

In the contest for Board District 2, AALA has endorsed **Lisa Alva** who is running against the incumbent and one other challenger. Lisa, an English teacher at Bravo Medical Magnet High School, is National Board Certified and has been teaching for 18 years. She says that her first priority "would be to redirect

funding, resources, and personnel to neighborhood public schools so that all children, especially at-risk youth, have enough variety in classes, and small enough classes, to benefit from a complete education that includes electives and vocational/technical training, from pre-K through adult school.” **Dr. Diane Ravitch**, noted educator and author, says that **Lisa Alva** “would be a valuable addition” to the Board of Education. She has been endorsed by the *Los Angeles Times* and believes each decision should be viewed in terms of how it will benefit students.



AALA endorses **Imelda Padilla**, one of six candidates running for the District 6 seat. She says, “I want to be on the school board because we need a school board member who puts the needs of parents and families ahead of everything else. I’m the only candidate in the race who has a proven track record of doing that — going to parent centers, hearing their stories, understanding their issues, and doing something about it. I don’t feel we have had that sort of representation before and I know I can bring it to the table. I will be able to hit the ground running to make sure parents, youth and families finally feel like they have an advocate on the board.” Imelda,

who grew up in Sun Valley and attended LAUSD schools, is a commissioner for the Los Angeles County Commission for Women and is currently a Masters in Public Administration student at CSUN. **Mónica Ratliff**, the current District 6 Board Member, who is vacating her seat to run for L.A. City Council, says of Imelda Padilla, “I have watched some of the community organizing she has done, and heard her speak, and she is a very impressive young woman...I think she would add an amazing voice to the school board.” Imelda Padilla is endorsed by United Teachers Los Angeles, California Schools Employees Association, Service Employees International Union Local 99, Teamsters Local 572, L.A. School Police, Los Angeles County Federation of Labor, Congressman **Tony Cardenas**, Secretary of State **Alex Padilla**, Senator **Robert Hertzberg**, Assemblyman **Raul Bocanegra**, Los Angeles County Supervisor **Sheila Kuehl**, Los Angeles City Councilwoman **Nury Martinez**, former LAUSD Board Member **Julie Korenstein**, and San Fernando Mayor **Robert Gonzales** and Councilman **Antonio Lopez**.

SECONDARY DIRECTOR RUN-OFF

Because no candidate received a majority vote in the recent election for the AALA Executive Board position of Secondary Director, a run-off election will be held next week. The two candidates for the position are **Rafael Gaeta** and **John Plevack**. Ballots will be emailed to all secondary members on Thursday, March 9, 2017, and are due by 5:00 p.m. on Wednesday, March 15.

HEALTH BENEFITS FAQ— HOW SERIOUS IS ANTIBIOTIC RESISTANCE?

The Centers for Disease Control (CDC) state that at least 2 million people in the U.S. annually contract an infectious disease that is resistant to antibiotic drugs. Antibiotics, or antimicrobials, have been used

effectively since the 1940s to treat infectious diseases. However, their wide use has caused many infectious organisms to adapt and resist the effects of the drugs. Drug-resistant infections are occurring worldwide and escalating, and in the United States, they cause at least 23,000 deaths each year.

What are the sources of infections?

Organisms, called “microbes,” too small for the eye to see, are found everywhere on earth. They are mostly harmless and even beneficial, but some can cause disease in humans and animals. Often referred to as “germs” or “bugs,” disease-causing microbes include bacteria, viruses, fungi, and parasites. Examples of disease-causing microbes comprise:

- Group A streptococcus - Strep throat bacteria
- Salmonella - Food poisoning bacteria
- Rhinovirus – Common cold virus
- Influenza virus – Flu virus
- Trichophyton – Athletes foot fungi
- Plasmodium – Malaria parasite

What types of infections can or cannot be effectively treated by antibiotic drugs?

Antibiotics should be used to treat bacterial infections, such as strep throat, some forms of pneumonia, sinus infections, urinary tract infections, and infected wounds. Antibiotics are not effective against viral infections like the common cold, most sore throats, flu, and fungus infections.

Why won't antibiotics kill viral infections?

Viral infections are hard to treat because viruses live inside your body's cells. They are "protected" from medicines, such as antibiotics, that move through your bloodstream. Antibiotics kill bacteria—both “bad” bacteria and “good” bacteria.

What causes drug resistance?

Overuse and misuse of antibiotic drugs are the major causes of drug resistance. According to the CDC, up to a half of the antibiotics prescribed are either unnecessary or inappropriate, with 47 million unnecessary antibiotic prescriptions written yearly in doctor's offices, emergency rooms, and hospital-based clinics. Drug-resistant forms of tuberculosis, gonorrhea, and staph infections are just a few of the dangers we now face.

What can the average person do to combat drug resistance?

- Ask for test/cultures to be done before getting prescribed an antibiotic; then take it exactly as prescribed.
- Do **not** demand antibiotics if your doctor says they are not needed.
- Don't use drugs prescribed for another person.
- Prevent infections by practicing good hygiene.

HR SELF-SERVICE FOR PRINCIPALS

The Human Resources and Information Technology Divisions are proud to announce a new feature that is available to all timekeepers and approvers: HR Self-Service for Principals. Now, school sites can generate their own real-time list of prescreened certificated candidates to interview.

One common concern with eligibility lists is that the information quickly becomes out of date as people are hired or their contact information changes. In order to keep your lists fresh, the new system does not display any candidates that have already been selected, and the system contains the most up-to-date contact information that is available to the District. For example, if an employee updates his/her phone number in ESS, the new phone number will show up on the eligibility list within a few hours.

Once a selection is made, the Intent to Hire form can be submitted electronically, and each school site can view the status of their submitted requests. To access this new feature, simply log into the SAP portal (<https://bts.lausd.net>) and click the "HR Self-Service" tab. You can even access it from home!

**CALSTRS MEMBERS: ELECTING AN OPTION CAN PROTECT
LOVED ONES BEFORE YOU RETIRE**

CalSTRS members who joined before January 1, 2013, are eligible to retire at age 55 with 5 years of service or before 55 with 30 years of service. At that time, whether they choose to retire or not, they have the opportunity to elect an option that will provide a monthly lifetime income for a loved one (does not have to be a relative) when they die; even if they die before retirement. This is called a preretirement option election. It will reduce the monthly amount received once the member retires, but will ensure that the beneficiary will start receiving a CalSTRS benefit whenever the member dies. There are advantages and disadvantages of choosing a preretirement election of an option.

ADVANTAGES

- If you die before retirement, your designee will receive a monthly payment from CalSTRS for the rest of his/her life.
- The amount your beneficiary receives will be higher if you choose the option prior to retirement.
- The career factor applies if you die before retirement.

DISADVANTAGES

- If you select a preretirement option and then cancel or change it before retiring, your retirement benefit may be reduced for life.
- If your beneficiary dies before you retire, the option is automatically canceled and your retirement benefit may be permanently reduced.
- If you change beneficiaries, due to either death or cancellation, you may have to pay an assessment.

CALPERS MEMBERS: OPTIONS AT RETIREMENT

CalPERS operates somewhat differently in the manner in which its members can provide for loved ones after their death. CalPERS members must wait until their retirement to make this decision. At that time, they can choose to take a reduced monthly benefit in retirement in order to provide a lifetime benefit for the person they designate. The reduction to the member's monthly benefit is based on the life expectancy of the member and the beneficiary. The younger the beneficiary, the greater the reduction. In most cases, only one beneficiary can be named and it cannot be changed after retirement, except under limited circumstances.

If a CalPERS member dies before retirement, the benefits to the survivor depend on whether the member was old enough to retire or not, similar to CalSTRS. The benefits may range from a full refund of the member's contributions plus interest and up to six months' pay or a lifetime monthly allowance equal to one-half of the service retirement that would have been issued if the person retired on the date of death.

IMPROVING LATINO KINDERGARTNERS' MATH SKILLS

A report issued in February from Child Trends Hispanic Institute, a nonprofit research center that provides information and guidance to improve outcomes for Latino children, has found that Latino children's math skills are three months behind those of white children at the start of kindergarten, primarily due to poverty. "Being from a low-income family, having parents with no education beyond high school, and living in a household where English is not the primary language spoken are all associated with lower math scores for Latino children starting kindergarten," the report stated. Given that twenty-five percent of the children in kindergarten in the country are Latino, and the majority in California and New Mexico, addressing this issue to insure that they are prepared for a technology-based economy is critical.

In terms of remediation, the report recommended that Latino children can easily improve their math skills by attending full-day kindergarten, having more children's books at home, and parents frequently practicing numbers with them. The report also identified some systemic barriers to improving all children's math skills, such as the widespread (yet inaccurate) belief that math ability is innate, math anxiety, and bias against minority students. To eliminate the deficit, the report recommended that high-quality early education be made accessible and more responsive to the needs of Latino children and that full-day kindergarten be available to all families, regardless of income or where they live. The education community was advised to improve the preparation of teachers so they can provide high-quality early math learning experiences, to use a structured math curriculum, and to give greater attention to the needs and strengths of dual language learners.




