## WE GET LETTERS

*I want to thank you for having the back of the Los Angeles School Police Department (LASPD). As a long time former (retired) member of the department, I was touched by your words and grateful for your support. In these trying times, your response to UTLA's call to eliminate LASPD was brave. Your response was greatly appreciated by past and present members of the organization.*

*If UTLA knew the history of LASPD, they would know the department was created because local law enforcement could not provide the level of service needed by the LAUSD. In general, municipal law enforcement does not like to work with minors. They prefer not dealing with juveniles. As a specialized agency, members of LASPD choose to work with community youths and the officers are highly trained in juvenile law.*

*Yes, LASPD officers enforce the law, but more importantly they are mentors and role models in the community they serve. Throughout my career with LASPD, I received many formal and informal accolades. The most meaningful accomplishments were helping students find their career paths and/or reach their goal. One student in particular chose a career in law enforcement. I mentored him through high school and now he's a Deputy Chief for L.A. County Sheriff's Department. This is just one story. There are hundreds, maybe thousands of similar stories that can be told by every past and present officer in the department. This is truly the most gratifying aspect of being an LASPD officer. Again, thank you very much for your support; it is greatly appreciated!*

Officer Chung's letter is an important reminder of the origin and the need for the Los Angeles School Police Department. Interestingly, the leadership from municipal law enforcement agencies still does not see working with schools and youth as one of their overarching priorities. This then begs some of the following questions:

1. What is the District's overall safety plan if school communities cannot count on LASPD to provide tactical, life-saving support?
2. How will the District ensure the thirteen law enforcement agencies within the District's boundaries will immediately respond to an emergency at a school?
3. Now that random searches are banned at secondary schools, what tools is the District providing to principals to ensure campus safety and the detection of dangerous weapons?
4. When will the District invite UTLA to the negotiations table and mandate that teachers do supervision before school, during passing periods, nutrition, lunch, and after school?

## **SAN DIEGO'S PLAN FOR REOPENING SCHOOLS**

On June 16, 2020, the San Diego Unified School District (SDUSD) Board of Education approved the plan for reopening of schools. The district is giving parents two options from which to choose as of the first day of the fall semester, August 31:

1. On-site learning – **full** return to school following public health guidelines, face masks, 6 feet distancing, etc. (or whatever the guidelines are come August)
2. Online learning, including options for voluntary scheduled visits to the school site

It is now up to the District's executive leadership to implement the plan with input from all stakeholders. Below is the information from the SDUSD that went to principals on June 17, 2020, soliciting their input.

Today, we encourage you to collaborate with your colleagues (elementary by cluster, mid-level, & high school) to create feedback notes. Some guiding questions to start your conversation may be:*

- *What wonderings do you have about the two learning options? What should we consider in planning the details?*
- *For the **On-Site Learning Option** in which students receive daily on campus instruction:*
  - *How can we implement this while adhering to health and safety guidelines presented in the Board Workshop?*
  - *What measures can be taken in classroom spaces?*
  - *What measure can be taken to maximize nonclassroom and outdoor spaces?*
  - *Can student cohorts in secondary schools reduce movement throughout the campus?*
- *For the **Online Learning Option** in which students learn virtually at home and can also prearrange on-site experiences if they choose to:*
  - *Which educators will provide online learning?*
  - *How can schools develop a process to offer voluntary on-site learning experiences?*

- Which faculty or staff members will be able to provide this on-site experience?
- What challenges might we face? What could be potential innovative solutions?
- What does this mean to your site and your cluster?
- What support will principals need from the district to lead this?

Please note: You are not expected to have answers to these questions. These are meant to be conversation starters to help you lead your school community and guide us in supporting you.

## **HEALTHCARE FAQs— WHAT BUSINESSES HAVE REOPENED IN LOS ANGELES?**

On June 1, 2020, the City of Los Angeles issued a revised *Safer at Home Order*, following guidelines set by the Los Angeles County of Public Health. Now in effect, the revised Order progressively allows more businesses to reopen, with the caveat that if health conditions change for the worse, the City may have to amend this Order to be more restrictive. In addition to the essential services already in place, this summary provides the reopening of businesses previously prohibited from operating, but only applies to those within the Los Angeles city limits. Remember that staying inside as much as possible is still the safest way to avoid infection.

### **What businesses are now allowed to reopen?**

- All retail businesses for curbside/door pick-up and delivery, as well as in-person shopping at 50% capacity. Includes retail at indoor and outdoor malls, swap meets, and flea markets
- Hair salons and barbershops
- Pet grooming and training retail businesses and mobile services (pets must be dropped off and picked up outside)
- Manufacturing that supports retail (with adherence to infection and distancing protocols)
- Plumbers, electricians, exterminators, custodial/janitorial workers, handyman services, funeral home workers and morticians, moving services, HVAC installers, carpenters, day laborers,

landscapers, gardeners, property managers, private security personnel, and others who provide services to maintain the safety, sanitation, and essential operation of properties and other essential activities

- Banks, credit unions, financial institutions, and insurance companies
- Organizations and businesses that provide food, shelter, social services, and other necessities of life for economically disadvantaged or otherwise needy individuals, including gang prevention and intervention and domestic violence agencies
- Faith-based organizations (limited to the lower of 25% of the building's capacity, or a maximum of 100 people)
- Laundromats/laundry service
- Drive-in movie theaters
- Newspapers, magazines, television, radio, podcasts, and journalism
- Educational institutions, including public and private K-12 schools, colleges, and universities – provided that physical distancing of six-feet per person is maintained to the greatest extent possible
- Businesses that supply or store products needed for people to work from home
- Utility companies/businesses that provide support, services, or supplies necessary to operate an essential business with strict physical distancing
- Individuals/businesses that ship or deliver groceries, food, beverages, or goods directly to residences or businesses
- Airlines, taxis, ride sharing services, car rental companies, and other private transportation services providing transportation services necessary for essential activities and other purposes expressly authorized in this Order
- Home-based care for disabled persons, seniors, adults, or children
- Residential facilities and shelters for disabled persons, seniors, adults, and children
- Professional services, such as legal, payroll or accounting services, when necessary to assist in compliance with legally mandated activities
- Hotels, motels, shared rental units, and similar facilities
- Military/defense contractors/FFRDC (Federally Funded Research and Development Centers)
- Childcare facilities providing services that enable employees exempted in this Order to work as permitted, under restrictions contained in the Order

## **PROFESSIONAL LEARNING AND LEADERSHIP DEVELOPMENT BRANCH**

### **IDENTIFICATION OF STAFF TO BE EVALUATED IN 2020-21**

Principals must indicate in the My Professional Growth System platform ([MyPGS](#)) which staff members will be evaluated next school year using Educator Development and Support: Teachers (EDST), Educator Development and Support: Non-Classroom Teachers (EDSNCT), Educator Development and Support: School Leaders (EDSSL), and Educator Development and Support: Counselors (EDSC).

## PLLD (Cont.)

Refer to the [frequency of evaluation policy](#) and [MyTeam reports](#) to ensure all staff are evaluated within district guidelines.

Staff members who are scheduled for evaluation must be notified by their administrator; MyPGS does not generate a notification email. Teachers and counselors may be notified early or in the fall semester (before September 18, 2020, the contractual deadline for notification).
