## THE LORRAINE BUSH STORY

Our own **Dan Basalone**, whom everyone knows and remembers as a consummate professional and all-around good guy, has taken the time from his busy retirement in Idaho to write this tribute (beginning with the next paragraph) to **Lorraine Bush** and no one can tell the story better! There are many take aways from Ms. Bush's epic and legendary years of service and dedication, however, there literally would be no Associated Administrators of Los Angeles without some of her courageous actions to insure the integrity of the organization. No amount of awards, accolades, and speeches can ever begin to capture her AMAZING sense and sensibility. Thank you Friends of AALA for honoring Ms. Bush with a 2021 Honorary Scholarship in her name.

After 42 years of dedicated service to AALA and the administrators of the Los Angeles Unified School District, Lorraine Bush is retiring. Administrators for more than two generations have known Lorraine for the quiet calm of her voice when they called the AALA office with a problem or concern, and they have known her as the greeter at awards dinners, retirement lunches, and annual member receptions. Lorraine's quiet efficiency kept her in the background at AALA events and did not bring attention to herself. As someone who has known Lorraine during her 42-year tenure first as bookkeeper and then office manager, I can attest that Lorraine has meant much more to AALA and its success as a union than any other individual. Therefore, it is a pleasure and a privilege to share Lorraine's story. Her AALA institutional memory is unique. Her story is the AALA story. And, as a Valley girl, Lorraine's story is also the story of what education in LAUSD means to all students who aspire to have a satisfying career.

Lorraine was raised in North Hollywood where she attended Lankershim ES until the fourth grade when her family moved to Northridge. There, she attended Winnetka ES, Sutter MS, Cleveland HS and then Pierce College. She got married in 1967 and, also, got her first job at Security Bank as a junior secretary in the trust department. Her husband enlisted in the Army and was assigned to Okinawa. She soon joined him for a year and a half in Okinawa. While there, she worked at the American Express Bank as secretary to the president and, also, on the post as a secretary for the facility engineers. When they returned to California, they started their family. Lorraine has two children, **Greg** and **Darlene**.

In 1979, she needed to go back to work. So, she went to North Valley Occupational Center to brush up on her shorthand and typing skills. While in class, her instructor knew of a job opening in North Hollywood. She interviewed for the position of bookkeeper for the Association of Elementary School Administrators (AESAs) and was hired. **Bert Vance** was the executive director, **Nadine Swanson** was the administrator, and **Florence Berke** was the office manager. In 1981, The Adult, Elementary, Secondary, and Supervisory associations merged into one association—Associated Administrators of Los Angeles (AALA). **Dave Schwartz** from the Secondary Department and Bert Vance from the Elementary Department were co-executive directors; **Jo Hofer** - Secondary Department, **Marydell Doan** - Elementary Department, **Hilario (Larry) Pena** - Supervisory Department, and **William (Bill) Kennedy** - Adult Department were department directors. After Bert Vance and Dave Schwartz retired, **Walker Brown** became the AALA executive director. Under Walker Brown, the clerical staff consisted of Florence Berke, **Joyce Lund**, **Gema Pivaral**, **Margie Ross**, and Lorraine. **Walt Ragan** was elected president, but he still held his District position of elementary principal, and he worked after hours conducting the AALA Executive Board and Representative Assembly meetings.

When **Dr. Eli Brent** was elected president in 1988, he was still working as principal at Sherman Oaks Center for Enriched Studies (SOCES). He changed the bylaws through a vote of the membership to make the job of president into a full-time paid position in the AALA office which meant that Walker Brown had to resign as Executive Director. Then, in 1991, under President Eli Brent, AALA became the collective bargaining unit for frontline managers in the District. Dues were no longer voluntary, and everyone in the AALA bargaining unit began to have dues automatically deducted from their warrants.

After Eli Brent retired, **Dr. Mike O'Sullivan** was elected president. He served for two three-year terms, and he set the precedent for presidents serving two terms. Mike was succeeded by **Dr. Judith Perez** and **Juan A. Flecha** in the terms that followed. Other great administrators worked on staff in the AALA office including **Dan Basalone**, **Michelle Bennett**, **Yvonne Davis**, **Doris Dillard**, **Jeri Durham**, **Al Fasani**, **Hugh Gottfried**, **Dr. Rosa Maria Hernandez**, **Dan Isaacs**, **Barbara La Branch**, **Charlotte Lerchenmuller**, **Sylvia Perea**, **Mike Perez**, **Jane Pollock**, **Steve Quon**, **Joe Scollo**, **Jack Silas**, **Grace Strauther**, **David Tokofsky**, and **Dr. Lillian Utsumi**. In addition to Gema Pivaral who has been on the clerical staff for 33 years, other clerical staff members have included **Javier Melendez**, **Gloria Souquette**, and **Cathy Vacca**. Members who called the AALA office have always been on a first name basis with the clerical staff.

For Lorraine, the time has gone by very fast. Her oldest child is 50, but she still looks as young as ever. Year after year for those of us who have been AALA members during her tenure, she was always the constant in the office. Presidents and other staff may come and go when their terms in office were completed, but Lorraine always had the institutional memory which allowed AALA traditions to continue annually without fail. The AALA awards dinner was always a highlight of the District end of year activities. The member receptions always kicked off the school year in September in style. Retired administrators were treated royally at the Cathedral or Dodger Stadium. Lorraine, Gema, Jane, Cathy and Gloria made these events annual traditions. And, all of these events, as well as the executive board meetings and representative assembly meetings were outstanding because of the office management leadership of Lorraine Bush. As someone who has worked with Lorraine in the AALA office and has known her for all these many years as a colleague and a friend, I sincerely believe that AALA owes its tradition of excellence in representing members in great measure to Lorraine's office leadership. ## HEALTHCARE FAQs— SUNSCREEN BASICS

### **Have there been any changes in FDA regulations regarding sunscreen ingredients?**

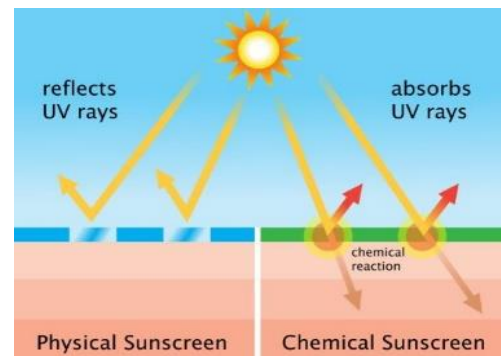
The most recent updates in sunscreen regulations were proposed in February 2019, when the agency announced that two of the 16 active ingredients used in sunscreens—titanium dioxide and zinc oxide—were recognized as safe and effective. Two ingredients—PABA and trolamine salicylate—were identified as **not** safe for use. Additionally, the FDA found insufficient data to show whether 12 other ingredients found in sunscreens were safe and called for additional research. Three years ago, the state of Hawaii legislated a ban on sunscreens containing oxybenzone and octinoxate. Key West, with the largest coral reef in the U.S., voted to ban sunscreens with oxybenzone and octinoxate effective January 1, 2021. Scientists found these chemicals to contribute to the bleaching and destruction of coral reefs. The FDA has not yet banned these and any other sunscreen ingredients, but last year began how much of the ingredient can be used in sunscreens.

### **What are the differences in sunscreens?**

There are two types of sunscreens—chemical and physical. Chemical sunscreens are the most common types sold on retail shelves. They contain organic compounds, such as oxybenzone, octinoxate, octisalate and avobenzone and work by absorbing UV rays and dissipating them. Physical sunscreens, often referred to as sunblocks, contain the active minerals such as titanium dioxide or zinc oxide. They work by sitting on top of the skin and deflecting UV rays.

### **What should I know about applying sunscreen before going on outdoor outings?**

- Don't rely on sunscreen alone to prevent skin cancer—combine sunscreen with protective clothing.
- Remember to wear sunglasses to protect your eyes.
- Follow label directions for use.
- Do not apply sunscreen on infants 6 months or younger.
- Apply generously to cover all exposed parts of your body, including your ears, back of neck, scalp, and tops of feet when wearing sandals. Wear sunscreen under clothing—a light T-shirt only provides SPF protection of about 5 to 8.
- Reapply two hours after the first application.
- Avoid inhaling mist when using spray-on sunscreen and avoid spraying near flame sources.

- If the pandemic kept you out of the sun, have your vitamin D level checked. Lower levels of vitamin D have been a pandemic-related health concern.

### **What are easy to remember tips about sunscreen?**

"Don't Fry Day," an awareness campaign sponsored every year on the Friday before Memorial Day, is very appropriate during this current heatwave. The message is:

- **Slip** on a shirt.
- **Slop** on broad spectrum sunscreen with SPF 15 or higher.
- **Slap** on a wide-brimmed hat.
- **Wrap** on sunglasses.

## **LAUSD IS HIRING RETIREES FOR INTERIM POSITIONS**

The LAUSD Human Resources website posts the following statement under Retiree Employment Information, *“It is critical to the academic success of our students to have an effective leader at every school. Therefore, we continue to leverage the experience and expertise of proven educators by processing retirees to work as interim administrators.”*

If you have been reading the AALA *Update* regularly you have seen the plethora of new positions that become available each week. To add to the normal turnover of positions, the Board just approved nearly 3,000 certificated and classified positions as part of the Path to Recovery Plan (see [Update Week of May 31, 2021](#)). As a result, there will be a number of personnel changes that will definitely impact school and office staffing patterns and the District is going to need the assistance of retirees to add stability to this process. Also, please remember that if you are just retiring this year, you cannot work for the first 180 calendar days following your retirement effective date.

## **TRAVELING THIS SUMMER? BE AWARE OF COVID-19 TRAVEL GUIDELINES**

*(The information below is reprinted from the U.S. Department of State Bureau of Consular Affairs website and was current as of June 15, 2021.)*

### **INFORMATION FOR TRAVELERS ENTERING THE UNITED STATES**

The [Centers of Disease Control and Prevention \(CDC\)](#) requires all air passengers entering the United States (**including U.S. citizens and Lawful Permanent Residents**) to present a negative COVID-19 test, taken within three calendar days of departure or proof of recovery from the virus within the last 90 days. Airlines must confirm the negative test result or proof of recovery for all passengers two years of age and over prior to boarding. Airlines must deny boarding of passengers who do not provide documentation of a negative test or recovery.

Please see the CDC’s [FAQ](#) for answers to questions about the requirement for proof of negative COVID-19 test or recovery from COVID-19 for all air passengers arriving in the United States. The CDC recommends that you do not travel internationally until you are fully vaccinated. International travel poses additional risks, and even fully vaccinated travelers might be at increased risk for getting and possibly spreading some COVID-19 variants. Delay travel and stay home to protect yourself and others from COVID-19. If you do travel, follow all CDC recommendations before, during, and after travel.

## **TRAVELING (Cont.)**

### **INFORMATION FOR VACCINATED TRAVELERS**

Your risk of contracting COVID-19 and developing severe symptoms may be lower if you are fully vaccinated with an FDA authorized vaccine. You still may be able to spread COVID-19 even if you are fully vaccinated. Travelers should consult with their personal physician if they have specific questions or concerns regarding their individual medical situation.

If you are fully vaccinated and are planning international travel, please consider the following:

- The CDC order requiring pre-departure testing to travel or return to the U.S. applies to all air travelers, even those who are fully vaccinated.
- If you test positive before travel to the United States, you will be denied boarding and may have to undergo a mandatory quarantine at your overseas location. Unexpected delays or quarantines may result in unexpected expenses for the traveler. Have a plan in case you have to remain overseas longer than anticipated. This includes being ready to cover additional lodging costs, flight ticket change fees, and any other additional expenses they may incur due to the unexpected extension. Travelers may find it difficult to access general medical care in another country as the pandemic has strained health care capacity in some areas.
- Border closures, airline disruptions, and other local restrictions may occur and could adversely impact your travel plans.

The CDC recommends that you do not travel internationally until you are fully vaccinated. [Please review additional CDC guidance for fully vaccinated travelers](#). The Department of State recommends U.S. citizens who travel internationally purchase travel insurance. To learn more, [please visit this page](#).

### **COUNTRY SPECIFIC COVID-19 UPDATES**

Global COVID-19 conditions are dynamic. U.S. citizens who choose to travel internationally may encounter mandatory COVID-19 testing requirements, quarantines, travel restrictions, and closed borders. Foreign governments in any country may implement restrictions with little notice. If you do travel internationally, be sure to make contingency plans as your trip may be severely disrupted and it may be difficult to arrange travel back to the United States.

The Department of State provides country-specific information and advice regarding COVID-19 as there are some restrictions on U.S. citizens and lawful permanent residents returning from certain countries. We update these resources whenever we receive new information, so please review these resources frequently:

If you are planning to travel overseas or if you are currently overseas and planning to return to the United States, you should contact your airline for specific information about testing requirements for travelers. Because airlines may adopt and modify their own specific policies to implement the CDC's testing rule, you should contact the carrier for your U.S.-bound flight and not rely on information from other carriers or information or experience from previous trips.

## **TRAVELING (Cont.)**

U.S. citizens, particularly travelers with underlying health conditions, should not travel by cruise ship at this time. The CDC notes there is increased risk of infection of COVID-19 on cruise ships. In order to curb the spread of COVID-19, many countries have implemented strict screening procedures that deny port entry rights to ships and prevent passengers from disembarking. Passengers with plans to travel by cruise ship should contact their cruise line companies directly for further information, continue to monitor the [www.travel.state.gov](http://www.travel.state.gov) website, and read the latest information from the CDC.
